Standards Writing Update

- Writing team is working hard and making steady progress- nearly 80% through licensing drafting
- Collaboration in the writing team both internal and external expertise
- Phase 1 written-Child Outcomes, Family Engagement and Partnerships, Professional Development and Training-moving forward this week for the next level of review
- Phase 2-Environments, Interactions and Curriculum, Administration and Oversight drafts will be completed by the end of March

Standards Writing Review

- First level review team has been reviewing for alignment of standards, content, progression, duplication, language consistency, incorporation of community feedback, DLL, cultural inclusion and CFOC standards
- Second level review will continue with this lens
- Third review team will be ensuring there are no gaps and consistency of standards

Standards Writing Example

Environments-Activities
Use of TV, video and/or computers

- If utilized-content, age and time limitations
- Writing guidance from FH WAC-no current Center WAC –aligned language for both programs
- Progression demonstrates education and active engagement with children if utilizing screen time

Standards Writing Example

Environments-Space and Furnishings Indoor Licensed Space

- Combined FH and Center language to align standards (35 sq ft and infant space 15 sq ft)
- Incorporated some ERS into WAC level in accordance with alignment recommendations
- EA level expands what more can be done in the space
- ECEAP standards already met at WAC level

Community Input Report Overview

Analyzing the Community Input Data

An analysis of the data collected from all of the focus groups and online surveys was conducted to understand the following questions:

- What proposed changes to align standards' are being promoted by the community?
- What are the key messages and broad feedback provided by the communities on standards alignment?
- What are the main ideas or themes that emerged in the community feedback?
- Are there qualitative and quantitative patterns or themes in the community feedback?

Community Input Report Overview

An analysis of the community input grouped together the main ideas and/or themes within each area of focus to identify the areas that have the most significant interest to the community based on how often that particular issue/feedback was raised in aggregate across all of the community feedback.

Through this process, the following themes were identified as having the highest priority in each of the content areas:


- Child Outcomes and Family Engagement: Developmental Screening; Dual Language Learners
- Environments: Furnishings for Routine Care, Learning, and Relaxation;
 Meals and Snacks
- Interactions: Expulsion; Discipline and Restraints
- Professional Development & Staff Support: Education Requirements
- Unaligned Licensing Standards: Administration

Community Input Report Overview

Data Limitations:

- Inequitable representation of participants
- Does not provide a full list of licensing, Early Achievers and ECEAP standards inconsistencies and duplications
- Does not fully consider inconsistencies and duplications with other standards, e.g. Head Start/Early Head Start, military, school age licensing, Montessori, etc.

Alignment Communication Plan
