Alignment Principles



Evaluation and Observation: ongoing evaluation and observation of the standards monitoring compliance in a variety of settings;

Simplicity: establish plain, consistent and measurable language for the standards;

Efficiency: eliminate duplication and inconsistencies in the standards;

Transparency: clearly defined levels that align with each other;

Community Engagement: an ongoing state to local collaboration process to seek stakeholders expertise;

Equity and Community Impact: be aware of racial, cultural, linguistic, and other education systems inequalities that impact the state opportunity gap populations;

Cultural Humility: maintain an interpersonal stance that is other-oriented (or open to the other) in relation to aspects of cultural identity that are most important to the [person].

WAC Draft, Professional Development, Training

- Pre-Service (initial training)
- Training Series: Enhancing the Quality of Early Learning
- In-Service (annual continuing education)
- Culturally Responsive Professional Development

Culturally Responsive Professional Development

- Embed the Culturally Responsive PD Guidelines (under development)
- Expand professional development opportunities in communities.
- Establish partnerships to enhance state-wide structure for delivery, especially as it relates to health and safety content.

WAC Draft, Professional Development, Training Licensing Pre-Service

Within 0-12 months

Pre-Service (before receiving initial license)

- STARS ID/ Registered in MERIT
 - Portable background check, education verified
- Licensing Orientation
- Safe Sleep (within 1st month of employment - I/T staff)
- Child Care Basics (within 6 months)
- 1st Aid/CPR
- Prevention of Exposure to Body Fluids
- DEL approved Child Restraint training

Within 6 months

- Strengthening Business Practice (administrators)

WAC Draft, Professional Development, Training Enhancing the Quality of Early Learning

A Professional Development Series

- Embed the current Early Achievers Level 2 training series into the continuum of professional development.
- Training series reflects foundational knowledge to enhance the quality of early care and education.
- Allow for 20 hours of learning that is completed once (year 2 of receiving license)

WAC Draft, Professional Development, Training In-Service

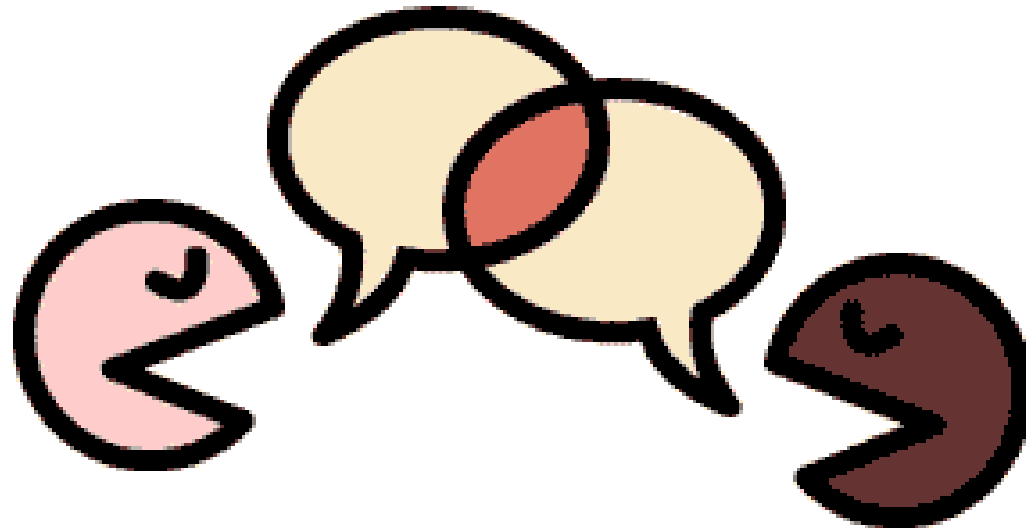
Annual Continuing Education

- Must be state approved training or with a higher education institution.
- In-service tracking begins fresh each year
- Renewal classes must be taken annually or every 3 years
- Annually complete 10 hours
 - Assigned/designated in-service hours tied to core competencies
 - Elective in-service hours on topics of interest
 - Administrators must complete 3/10 annual hours on Professional Development and Leadership

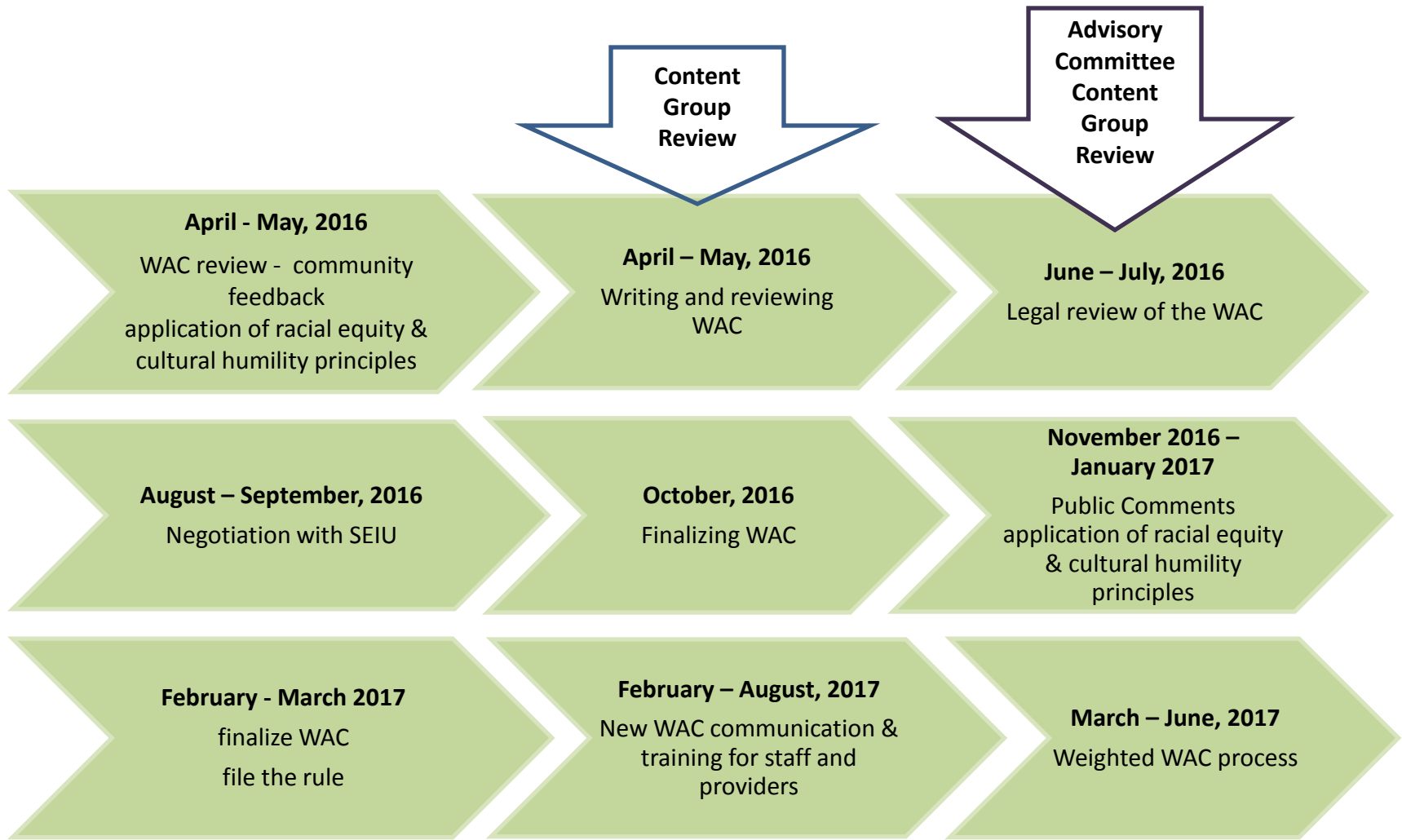
Renewal every 3 years

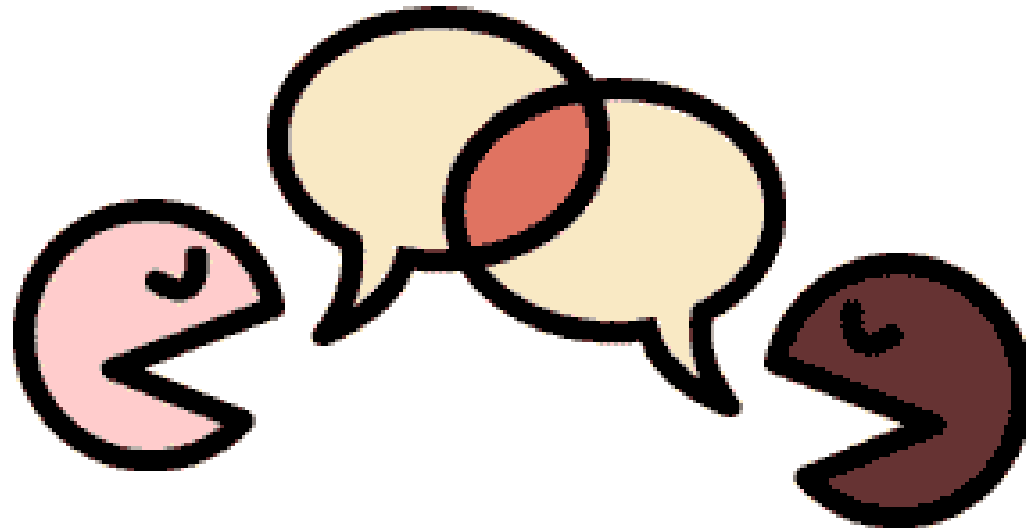

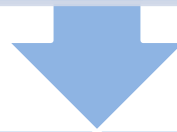
