Family, Friend and Neighbor (FFN) Provider Training Requirements

Family, Friend and Neighbor (FFN) providers have to meet training requirements if they are serving children receiving state subsidy. Non-relative, "friend and neighbor" providers have 90 days from date of authorization to complete and record health and safety training. See the complete list of training below.

The below three trainings are ONLY required for non-relative FFN providers



DCYF Approved Health and Safety Training Only for non-relative FFN providers (2 hours long)

DCYF Safe Sleep Training

Only for non-relative FFN providers caring for infants (1 hour long)

Infant, Child, And Adult First Aid and Cardiopulmonary Resuscitation (CPR)

Only for non-relative FFN providers (6-8 hours long)

First Aid and CPR trainings are not offered by DCYF. This training must be taken in person and the provider must demonstrate learned skills to the instructor. To find training in your community, contact community organizations like The Red Cross, your local fire department, churches, colleges, etc., or search the internet for additional options.



The training below is required for all FFN providers



Mandatory Subsidy Billing Training For both relative and non-relative

FFN providers (4 hours long)

The Subsidy Billing training is available in-person, online or through self-paced correspondence in English, Spanish and Somali.
