Melele ko jen Burokraam eo an Early Support for Infants and Toddlers (Jibañ eo Emōkaj ñan Niñniñ im Ajiri Jidik, ESIT)

Kōjberbal laajrakin kapeel ko emōj kile, Washington Sensory Disabilities Services (Jibañ ikijen Utamwe in Enjaak, Roñjak, Lolakijen, Nemaik, im Āt Bwin Jabdewōt ilo Washington, WSDS) ear kōmmane Three-Pronged Approach (Kōtōbar eo Jilu Mōttan, TPA) einwōt juon kein jberbal in jeiki abnōnō ko an jinen im jemen ajiri, muten niñniñ ko rej loi, im kapeel ilo aer eddeklok ikijen roñjak im lolakijen.



Wūnin kein jberbal in ej jilu mōttan:

1. Ñan kōlablok an ro rej lelok jibañ in ESIT melele kin mennin uwōta ko remaron jelōte an juon ajiri lolakijen im/ak roñjak.
2. Ñan lelok kein kamool ke emōj aer lale ak “etale” an ajiri eo roñjak im lolakijen.
3. Ñan lale ien eo roñjak im/ak lolakijen eo an juon ajiri aikuj bar juon etale in kakōlkōl elablok.

Kōtōbar eo elablok ej ñan kalikar abnōnō in roñjak im lolakijen ilo ien eo emōkajata ñan kadiklok an jelōte eddeklok eo an ajiri eo.

Three-Pronged Approach (Kōtōbar eo Jilu Mōttan) ear jab kōmman ñan binej jenkwān madmōdin etale ko rej an armij lomnak. Emmonlok, emaron jberbal ilo an kobalok ibben etale kin lale an lojilñi eo roñ ainikien ko (OAE), etale pija ko ej loi kin mejan, im/ak kakōlkōl in etale jen juon taktō in roñjak an ajiri, taktō in māj ko. Ekkā, bōtab, TPA eo ej wāween eo wōt ewōr ñan an ro rej lelok jibañ in ESIT kakōlkōl kin wāween an lolakijen im roñjak im jeiki melele ko, ilo juon wōt jikin, melele ko ikijen an roñjak im lolakijen.

ESIT ej aikuj melele eo ikijen roñjak im lolakijen an tōrre in bwe ren koba ilo aaleb Individualized Family Service Plan (Bebe in Jibañ an Kajojo Baamle, IFSP) an kajojo ajiri. Emōj kar kōjejet an kōmman TPA eo ñan ESIT im ej aikuj jberbal ñan bōk melele eo einwōt mōttan madmōdin bōk melele eo an baamle eo im kajojo yiō tōkelik, ilo an jeje jemlok ko iloan IFSP eo.
